Further to our previous correspondence regarding your request for the following information:

Please note the information I am requesting is not limited to whether the organisation utilises the terminology or classification of UFO/UAP/AD/NHI but rather whether it holds information on phenomena, detections and objects which meet some or all of the characteristics I have described. Thus I am looking for information on UFO/UAP/AD/NHI as defined above, regardless of whether the organisation uses that terminology.

I politely request any and all communications, records, files, documents, data, and experimental data in any form of media concerning, related or pertaining to any and all of the following topics:

Reporting, investigation, threat analysis and mitigation of UAP flight safety risks and actual or near mid-air collisions with UAP/UFO and the signatures and detections related to those events. This includes any statistics related to UAP and flight safety and accidents. Or any reports of security incidents, incursions, incidents or experiences with UAP by personnel or reported to personnel be they formal or informal.

Media and public relations strategy, strategic media policy concerning public interest in and developments in the United States concerning UAP/UFO/AD. In particular the 'Congressional hearing on Unidentified Phenomenon', held July 26th, 2023.

David Grusch and David Grusch's allegations

Strategy, policy and internal communications related to freedom of information requests concerning UAP/UFO/AD.

Canadian MP Barry Maguire statements:

"I am writing to recommend you request a classified briefing, containing full sensitive and protected program information from your officials on the Government of Canada's historical and ongoing efforts on analyzing recovered UAP material." "Recovered foreign material is studied through the Five Eyes Foreign Material Program (FMP) which, in Canada, is sponsored by the Canadian Forces Intelligence Command aligned with several intelligence sharing arrangements and treaties."

'All Domain Anomaly Resolution Office' (AARO) and Dr. Sean Kirkpatrick's statement that "I have just held our first five eyes forum on the subject (UAPs) last week".
A or the 'foreign materials programme' (FMP).



*Data sharing, contact or operations involving UAP/UFO/AD with other nations
Or data sharing, contact or operations with other nations concerning the study, exploitation,
recovery, reverse-engineering and investigation of material, phenomena or entities of an unknown
origin or an origin attributed to a consciousness/intelligence which is other than or subsumes
humanity or human consciousness/intelligence as it exists today.*

*The implications or consequences of UAP or non-human intelligence (NHI) topics related to
either or a component of the National Defence Authorisation Act (NDAA) 2023, or NDAA 2024 of the
United States Congress*

*Experiments or plans to experiment relating to zero-point energy (the lowest possible energy
state of a quantum vacuum) or exploiting zero-point energy for energy creation or propulsion.
Further, any information related to the use of electromagnetic field production as a means of
creating positive lift/propulsion. Experiments/data relating to inertial
mass reduction devices, plasma compression fusion devices and high-energy electromagnetic field
generators.*

*Any communication or records concerning the investigation, examination and evaluation of
material or entities of an unknown origin or an origin attributed to a consciousness/intelligence
other than or that subsumes humanity or human consciousness/intelligence as it exists today. This
includes 'meta-materials' or 'biologics' which have come into
the organisation's possession about which the organisation does not know its prime origin or is
known and attributed to NHI.*

*Any interaction, investigation or experimentation and data of any kind which have come into
the organisation's possession where the origin or nature of the material is unclear, unknown or
attributed to a consciousness/intelligence which is other than or subsumes humanity or human
consciousness/intelligence as it exists today or is anomalous or falls
under the definition of UFO/UAP/AD as defined above.*

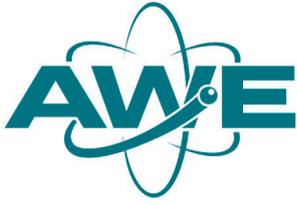
Your request has been handled as a request for information under the Freedom of Information Act 2000 (the Act).
